MINISTER'S STATEMENT OF COMMITMENT #2

I, the undersigned, do understand that the Stephen Fraser Ministries (Family of Faith Fellowship, Inc.) Ministerial Credential Program primarily exists for the purpose of advancing the vision, mission, and purpose of this ecclesiastical Christian ministry, and effectively advances the tax-exempt purposes of this 501(c)(3) nonprofit tax-exempt organization.

I realize that by receiving credentials from Stephen Fraser Ministries, I am entering a covenant to live a clean, pure, holy, and upright life that will honor the Lord Jesus Christ, Stephen Fraser Ministries, and my fellow gospel ministers. My ministerial behavior and conduct of duties must be performed with utmost accuracy, professionalism, excellence, and always in line with the Holy Scriptures.

I am willing to accept the leadership of Dr. Stephen Fraser, and will allow him to speak into my life and ministry. I commit to attending at least one major conference hosted by Stephen Fraser Ministries or Life of Faith Bible Church each year. (i.e., Holy Spirit Meetings, Healing & Miracle Meetings, You Glow Girl Conference, or another Special event).

I understand that I have a financial commitment and accept the responsibility of consistent financial accountability, as well as steady support, to Stephen Fraser Ministries or Life of Faith Bible Church, to give and/or tithe regularly.

I further understand that Stephen Fraser Ministries (Family of Faith Fellowship, Inc.) is an ecclesiastical corporation, and that in order to preserve the function and integrity of the Corporation as the body of Christ, and to provide a biblical role model to the members, my fellow ministers, and the communities we serve, it is imperative that all persons holding ministerial credentials in any capacity should abide by and agree to the *SFM Statement of Faith & Doctrine* (the Corporation's Religious Beliefs and Tenets) and conduct themselves accordingly.

I fully understand that I am NOT authorized to provide ministerial services and/or perform sacerdotal functions contrary to the SFM Statement of Faith & Doctrine, the Christian faith, and the Holy Scriptures (the authorized King James Version of the Bible). I understand that I am NOT required, nor legally authorized, to provide (and must specifically choose against the provision of) services to any individual(s) if such request is in violation of these religious beliefs and tenets. However, any and all decisions pertaining to providing such services shall be carried out in a manner that promotes the salvation (the redemption of man from the bondage of sin and the biblical acceptance of the provision of Jesus Christ for eternal life) of all persons.

I understand that if I do not abide by the Corporation's beliefs and tenets as clearly documented in the *SFM Statement of Faith & Doctrine*, and the moment that I violate these established beliefs and tenets, my credentials are automatically revoked, and the authorization to function granted to me by the SFM Ordination Board is immediately rescinded.

I attest to the fact that I have read, understand, and agree with the *SFM Statement of Faith & Doctrine*, and, as a condition of holding credentials, I commit to abide by the Corporation's Religious Beliefs and Tenets, the *Requirements for Credentials*, and the policies and procedures of the SFM Credential Program and conduct myself accordingly.
