



# MEDICAL AUTHORIZATION & RELEASE/WAIVER OF LIABILITY

## NSPIRE CHURCH, INC.

A COMPLETED WAIVER IS REQUIRED FOR EVERY NSPIRE STUDENT. SIGNING THIS WAIVER INDICATES THAT YOU HAVE READ, UNDERSTOOD, AND AGREE TO THE WAIVER.

The undersigned participant ("Participant") in NSPIRE activities, sponsored by NSPIRE Church, and Participant's parent(s) or legal guardian(s), in consideration of the benefits received from Participant's participation in NSPIRE activities, individually affirm and agree for the time period from January 1, 2026-December 31, 2026 that:

1. Acknowledgment of Risk. I fully understand and acknowledge that participating in NSPIRE activities may entail hazards, dangers, and other risks to bodily health, safety, and well-being. Such activities, risks, hazards, and dangers may include, but are not limited to, the following: inflatable game activities, dehydration, general transportation issues, hotel safety, city threats, exposure to illness, theft/loss of personal belongings, loud music, exposure with homeless individuals, protesters, and crowded areas, etc. I understand that the risks and dangers inherent in these activities may be caused by the negligence of Participant in the activity, the negligence of others, accidents, breaches of contract, forces of nature, human hostilities, or other causes, and knowingly accept those risks.

2. Obligations of the Participant. As a condition of participating in NSPIRE, Participant shall (1) learn and consistently follow the rules governing NSPIRE and its associated activities, (2) obey all instructions of NSPIRE staff and volunteers, and (3) alert NSPIRE staff immediately of any dangers or hazards to the safety of any individual(s) in NSPIRE that Participant perceives.

3. Permission. I give permission for Participant to participate in NSPIRE and all of its associated activities, including but not limited to those described in Section 1, above. I also authorize NSPIRE, its agents, and any agencies working in conjunction with this event to provide medical treatment to Participant, as specified below in Section 5, below, "Medical Authorization."

4. Liability Waiver/Release. In consideration of Participant's participation in NSPIRE, and intending to be legally bound, I hereby, for myself, my heirs, executors, and administrators, assume all risks and dangers identified above and hereby agree to release and hold harmless NSPIRE, its employees, and volunteers from any and all liabilities, claims, demands, actions, or losses for or from bodily injury, property damage, sickness, wrongful death, loss of services, or otherwise, which may arise out of Participant's participation in NSPIRE or related activities and which may arise out of Participant's participating in any activity associated with NSPIRE.

5. Medical Authorization and Release. I understand that NSPIRE Church will make every effort to contact Participant's parent(s) and/or guardian(s) in the event of a medical emergency. Nevertheless, I hereby give permission and authorize NSPIRE representatives, at any time they believe an emergency exists, to provide, facilitate, and consent to the provision of any first aid, doctor's care, hospitalization, surgery, transportation to medical facility, and/or any other form of medical care or treatment that NSPIRE determines that Participant may need because of illness, injury, or other health problems that Participant may suffer while participating in NSPIRE or its associated activities. I agree to be financially responsible for any medical bills incurred as a result of medical treatment for Participant. I agree to release and hold harmless NSPIRE and its employees and volunteers from any claims, liabilities, actions, demands, or losses for or from bodily injury, property damage, wrongful death, or
