Once received Crafter fees are NOT refundable unless the event is canceled by LSPH. Application is not considered complete until payment is received. Crafter space(s) will be assigned prior to the date of the event based on the items for sale as described on the application and payment is received. We will do our best to make sure similar crafters are not next to each other. In the event of a late cancellation, we will fill the spot with a crafter which may or may not have similar items. .

Crafters will comply with directions & requests of the LSPH staff and volunteers. Non-compliant Crafters will not be permitted to return. We work to insure effortless arrival/departures for all crafters, as well as safety for all participants.
