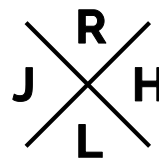

The undersigned do hereby give permission for our (my) child, \_\_\_\_\_, to attend and participate in activities sponsored by RiverLakes Community Church. We (I) authorize an adult, in whose care the minor has been entrusted, to consent to any medical or hospital treatment, including but not limited to x-ray examination, anesthetic, surgical or dental diagnosis or treatment, to be rendered to the minor under the general or special supervision and on the advice of any physician or dentist licensed under the provisions of the Medical Practice Act on the medical staff of a licensed hospital, whether such diagnosis or treatment is rendered at the office of said physician or at said hospital.

The undersigned shall be liable and agree(s) to pay all costs and expenses incurred in connection with such medical and dental services rendered to the aforementioned child pursuant to this authorization.

We (I) (and for and on behalf of my child-participant if said child is not 18 years of age or older) do hereby release, forever discharge and agree to hold harmless RiverLakes Community Church and the directors thereof from any and all liability, claims or demands for personal injury, sickness or death, as well as property damage and expenses, of any nature whatsoever which may be incurred by the undersigned and the child-participant that occur while said child is participating in any trip or activity. We (I) hereby assume all risk of personal injury, sickness, death, and damage as a result of participation in any RiverLakes Community Church activity.

The undersigned further hereby agree to hold harmless and indemnify RiverLakes Community Church, its directors, employees, and agents, for any liability sustained by RiverLakes Community Church as is the result of the negligent, willful or intentional acts of said participant, including expenses incurred.

Should it be necessary for our (my) child to return home due to medical or disciplinary reasons or otherwise, the undersigned shall assume all transportation costs.

The undersigned does also hereby give permission for our (my) child to ride in any vehicle designated by the adult in whose care the minor has been entrusted while attending and participating in activities sponsored by RiverLakes Community Church. Authorization and permission is hereby given to RiverLakes Community Church to furnish any necessary food and lodgings for this participant.

We (I) understand that photographs of the activity will be taken and I hereby give RiverLakes Community Church and their legal representatives and assigns the right and permission to publish the picture of my child-participant on its World Wide Web site or in other official RiverLakes Community Church printed publications without further consideration, and I acknowledge the church's right to crop or treat the photograph at its discretion. I also acknowledge that the church may choose not to use the photo(s) at this time, but may do so at its own discretion at a later date. In giving my consent, I hereby release and hold harmless RiverLakes Community Church and their office employees from any and all responsibility or liability. I understand that neither I nor my child-participant will receive compensation should any photographs of my child-participant be used.

**Dress Code:** As a participant in a RiverLakes community Church activity, I agree to dress appropriately for the event. I will cheerfully and willingly change if leaders deem my clothing inappropriate. Specifically as a female, I agree to wear a modest, one-piece bathing suit when swimming is permitted. Likewise, as a female, I agree to avoid "revealing" and extremely tight clothing. I agree to wear no spaghetti strap tank tops, no tube tops, no short shorts, and to not have bra straps showing. Specifically as a male, I agree to keep my shirt on whenever not directly participating in a water front activity. Likewise, as a male, I agree to avoid overly baggy pants that reveal my underwear. I agree to wear no logo or t-shirt design that may be seen as vulgar or disrespectful.

**Discipline Code:** Scripture is clear that God expects Christians to respect and obey those in authority (Romans 13:1-6; Hebrews 13:17). At RiverLakes Student Ministry activities, those in authority include leaders from RiverLakes and other groups we may join. In all situations "first time obedience" is expected. If a leader asks you to do something or stop doing something, you are to respond accordingly the first time you are asked. If you do not properly respond, the consequences include, but are not limited to, losing the privilege of participating in activities. Repeated violations and violations of a severe nature, such as alcohol or drug use, open defiance, etc., may require you to return home before the end of the activity, event or trip without reimbursement. Your parents will be notified, and the hope and confidence of RiverLakes leaders that discipline issues will be minimal. However, if problems occur, we are prepared to deal with each incident.
