The ministry transitioned to a unified digital platform with a redesigned website, along with new mobile and TV apps, integrating systems for content delivery, event registration, and online giving. Legacy Imperative also hosted live events to train grandparents in spiritual leadership and faith conversations, while maintaining engagement through podcasts, quarterly newsletters, and donor communications.
