MISSION STATEMENT

Not Forgotten is a 501(c)3 nonprofit organization that is compelled by the love of Christ to provide for the physical, educational, emotional, and spiritual needs of impoverished, abandoned, and oppressed people of the world, so that they may find salvation through Jesus Christ, improve their quality of life, and be empowered to affect change in their communities.

OUR STORY

In a city with high levels of substance abuse, sexual immorality, unemployment, large families, and low marriage rates, boys are often told that they must either contribute to the family income or fend for themselves so the rest of the family can survive. From a young age, these boys are asked to daily sacrifice their childhood and their education with the aim of working in some way to support their families. Historically, if they cannot add to the family's livelihood by finding work, they are left with the alternative of fending for themselves on the streets. These boys have frequently faced one of two options in order to survive: stealing or selling themselves.

Not Forgotten was founded by a group of individuals who were profoundly affected by children with this story. These individuals began to dream of ways to respond to the harsh reality they had personally encountered. They met local Peruvians who shared their desire for providing for these children's physical, educational, emotional, and spiritual needs. Not Forgotten became an official nonprofit in 2007, beginning its work by partnering with existing children's homes in Iquitos. In 2011, Not Forgotten purchased 100 acres of land, and began construction of a children's home in response to the great need in the area, and with the goal of providing holistic care to the children who would one day reside there.

In February 2015, after years of planning, construction, and training, Not Forgotten saw the first children come to live at Las Lomas. While we are saddened by the need that brings these boys to our home we are thankful and humbled that they have come to a place where we know they will be well cared for and hear the truth of the gospel of Jesus Christ. Thank you for partnering with us to accomplishing this mission!

OUR VISION

Not Forgotten has been planning and preparing a place that we pray will be a light not only to vulnerable children, but also to the surrounding community just outside of lquitos, Peru. With this purpose in mind, we purchased the land now known as Las Lomas.

In 2015, we opened the first of several family-style homes for children at Las Lomas. Rather than an institutional-style orphanage, children will be raised in a traditional family environment by loving caregivers. Our goal is to create a place where these children can grow up safely, obtain spiritual and psychological guidance, receive a quality education, and be empowered to affect change in their community.

The family-style homes will house up to eight children per home and one pair of resident house parents. Along with the needed bedrooms and baths, each home will be furnished with a kitchen and a shared living area for the children and house parents. Each child at Las Lomas will be given their own bed, desk, and personal storage space for clothes and any other belongings.

NOT FORGOTTEN WORK TEAMS

WHO CAN GO?

- You must be at least 18 years of age to participate in a trip.
- Those ages 12 to 18 years of age may join a trip if accompanied by a parent or legal guardian and with approval by Not Forgotten staff.
- If you have not participated in a previous trip and are not a member of one of our partner churches or organizations, we ask that you have a brief phone interview with our staff to ensure the trip aligns with your desires and interests.
- Due to high risk to both mother and baby we do not allow women who are pregnant to participate in our trips.

WHY DO WE GO?

- The purpose of our work teams is to support, encourage, serve, and love the children and staff of Not Forgotten as well as share the hope of Jesus Christ through both word and action to all we meet along the way.
- We hope to build lasting relationships with the children and people with whom we work that remind them that they are not forgotten, and to be a tangible demonstration of how valuable these children are to Christ.

WHAT WILL WE DO?

- We accomplish our goals through various construction projects, organized crafts and games, educational activities, special excursions, conversations, laughter, and the building of long-lasting relationships.
- While we often undertake construction projects during the trip, the completion of these projects is not the ultimate goal of our trips and is secondary to the above-mentioned purpose.

WHERE WILL WE GO?

- We will be traveling to and working in Iquitos, Peru and the surrounding communities.
- The last night we will be staying in Lima, Peru before returning home.

WHEN WILL WE GO?

• July 15th - 23rd, 2023

HOW MANY GO?

• We recommend a team of 10-20 people.

HOW MUCH WILL A TRIP COST?

- Approximately \$2600-\$3000. This total includes international airfare, transportation within Peru, construction supplies, food, lodging, luggage fees, and travel insurance. We do our best to keep the cost of each trip as low as possible without compromising the integrity or safety of the ministry or our team members.
- Please note: this trip cost <u>does not</u> include background check, vaccinations, malaria medication, meals before arrival in Lima, or souvenirs you wish to purchase in Peru.

Work Team Preparation

Required Paperwork

Work Team Application:

Not Forgotten staff must receive a completed application before your place is secure on the team. Your full name on the work team application should **<u>exactly</u>** match the name listed on your passport. Any discrepancies in spelling could complicate international travel.

Team Covenant:

Every team member is asked to read and sign the team covenant included in this packet. This covenant outlines basic rules and expectations that should be followed and honored on our trip to Peru. Any behavior that goes against the signed covenant could result in an early departure home, at your expense, by discretion of Not Forgotten staff and team leaders.

Release Forms:

Everyone must complete the Release and Covenant Not to Sue Form and the Permission to Treat Form. **These forms must be notarized**!

Passport Copy:

Everyone must submit a copy of your passport.

Background Check

The protection of the children we serve is our biggest priority. All team members must complete a background check prior to being approved as a team member. You can complete the background check by going to https://bib.com/SecureVolunteer/NOT-FORGOTTEN/.

Payment Information

All donations for Not Forgotten work teams are tax deductible. To guarantee that those who make donations receive their receipts, please be sure to have current addresses on all checks.

Team Meetings

You will be expected to participate in all team meetings organized by Not Forgotten or your respective church or organization. If you cannot attend a team meeting you will be expected to learn the information discussed.

TENTATIVE TRIP SCHEDULE

Saturday, July 15th

Depart from US. Will have an overnight flight to Lima, Peru.

Sunday, July 16th

Depart from Lima and fly to Iquitos, Peru.

Monday, July 17th – Saturday, July 22nd

Work Days – Time will be spent doing projects and activities in and around lquitos, Peru. Exact day-to-day schedule and types of activities will be determined closer to the trip departure depending on current needs and team composition.

Saturday, July 22nd

Depart Iquitos and fly to Lima. We will spend the night in the airport hotel.

Sunday, July 23rd

Fly back to the US.

Frequently Asked Questions

What will we do on a Not Forgotten mission trip?

While trips can differ in focus, generally our work teams seek to glorify the Lord by serving the children with whom we work and furthering the development of Not Forgotten's property, Las Lomas. We accomplish our goals through various construction projects, organized crafts and games, educational activities, special excursions, conversations, laughter, and the building of long-lasting relationships. Our mornings typically involve work on various construction projects, and our afternoons are filled with quality time with the children. Occasionally, work teams will also organize vacation bible school lessons/crafts, sports activities, or hold English classes.

How do I pay for the trip?

Each team member is responsible for paying for the entire cost of his or her trip. Often, members chose to raise their own financial support through their friends and family. While this task may seem daunting, it is a unique opportunity to see God provide in ways that will strengthen the faith of those going on the trip. This is typically done through writing letters or asking people to contribute toward the trip.

How is the cost determined?

Depending on the time of year and cost of airfare, our trips range from \$2000-\$2500. Trip cost includes international airfare, transportation within Peru, construction supplies, food, lodging, baggage fees, administration fees, background checks, and travel insurance. This *does not* include vaccinations, malaria medication, passport fees, food in airports, or the cost of souvenirs. Please know that every effort is made to minimize costs without jeopardizing the quality, effectiveness, or safety of our teams.

Are gifts tax-deductible?

Yes. Not Forgotten is a 501(c)(3) tax-exempt organization (tax ID 26-0734351).

If I decide to cancel my involvement in the trip, can I get my money back?

According to tax codes/laws, tax-deductible contributions are non-refundable. These funds will, however, stay in the short-term missions fund and can be used for future trips or can be repurposed for other use. If you cancel your involvement after airfare has been purchased, you will be expected to cover all of the fees, penalties, and losses incurred by that point. If Not Forgotten cancels the trip your donations will be refunded.

Will I need any vaccinations or medication?

Yes.

<u>Vaccinations:</u> We recommend that you discuss vaccinations for travel with your doctor. Generally, we follow <u>CDC guidelines and recommendations</u> for vaccinations that can be found online at http:// wwwnc.cdc.gov/travel/destinations/traveler/mission_disaster/peru. We recognize that each individual is different and health care needs/situations may vary. If you have any questions about vaccinations please feel free to contact us.

<u>Medication:</u> We will be traveling in areas where malaria is present. We recommend that you discuss antimalarial medications with your doctor. You will be responsible for obtaining your own malaria medication before departure.

What about travel insurance?

Travel insurance is purchased for you by Not Forgotten, and is included in the cost of your trip.

LADIES:

<u>Shirts:</u> sleeveless shirts are fine as long as the neckline is conservative (when standing or bending over) and the armholes are not abnormally gaping. No spaghetti-straps unless you have a thicker-strapped sports bra underneath.

<u>Shorts:</u> athletic shorts are fine as long as they are modest. Fingertip length or longer is a good standard. Be mindful of slits. Make sure the shorts cover you well when you are bending over, squatting, moving around, or standing on something high.

<u>Swimsuits:</u> one-pieces or tankinis that overlap and do not show any stomach are appropriate. Watch necklines – remember you will be playing with little boys in the water who will be pulling at and climbing all over you. Wear a dark-colored shirt in the water if there's reason for concern.

Not Forgotten Covenant Form

I realize that the following principles are crucial to the effectiveness, quality, and safety of our mission together. As a member of this mission team, I promise and covenant, by God's abounding grace, to:

- 1. Remember that I am a representative of Not Forgotten and Jesus Christ, and as such I will seek to represent the spiritual values, moral conduct, and likeness to Christ that are embraced and embodied in that assembly.
- 2. Remember that I am a guest working at the invitation of Not Forgotten and the personnel in the host country. I agree to respect and support their leadership.
- 3. Remember that I have come not only to help, but also to learn. I may be exposed to procedures and practices that I feel are ineffective or insufficient. I may also be confronted by attitudes that I feel are narrow or close-minded. As this occurs I will resist the temptation to "correct" my hosts and inform them about "how things are done back in the United States." I will instead be open to the opportunity of learning another culture's methods and ideas.
- Respect my hosts' culture and distinctive practices of Christianity. I recognize that the Christian faith has 4. many different faces throughout the world, and that one of the purposes of my trip is to witness and experience faith lived out in a different culture.
- 5. Develop and consistently maintain a servant's attitude toward all nationals and my teammates.
- 6. Respect our team leader(s) and their decisions.
- Refrain from gossip and keep my promise of giving only good reports. If there are policies and decisions 7. made by the leaders with which I disagree or do not understand, I will go to the team leaders in private and make my concerns known to them rather than to other team members. In so doing, I will avoid the possibility of sowing seeds of dissension and division.
- 8. Be patient, forbearing, and forgiving toward the shortcomings of the other members on the team.
- 9. Refrain from complaining. I realize that travel can present numerous unexpected and undesirable circumstances, but the rewards of conquering such circumstances are desirable. I will resolve to be flexible, supportive, and adaptive on such occasions rather than grumbling when circumstances are difficult.
- 10. Respect the work that is going on in the host country with its pastors and leaders. I realize that our team will be there for just a short time, but the local church is there long term. I will respect their knowledge, insights, and instructions.
- 11. Refrain from negative comments or hostile discussions concerning the host country's politics and culture.
- 12. Remember not to be exclusive in my relationships with the team. If my sweetheart or spouse is on the team we will make every effort to interact regularly with all team members of the team.
- 13. Refrain from activity or undue interest that could be construed as a romantic interest toward a national. I realize that certain actions that seem innocent in my own culture may be inappropriate in another culture.
- 14. Refrain from any consumption of alcoholic beverages, including beer, wine, and liquors. While this is not an attempt to bind the conscience. I understand that such indulgence may cause another to stumble. I realize and accept that failure to adhere to this mandate will result in my exclusion from further short-term trips with Not Forgotten, and could result in my immediate departure home, at my own expense.
- 15. Refrain from use of any tobacco or tobacco related products.
- 16. Seek to live and exemplary life of holiness and obedience to God's commands.
