Tuition charges are by the year. If tuition is paid in full by August 1st, the family will receive a 3% discount. If not paid in full, 10 monthly payments may be made, with the first payment due **August 1st**, or at the time of enrollment if it is after August 1st. ***Tuition payments are then due the first of each month through May.***

Tuition payments received after the first of each month are late. A late charge of \$35.00 per family will be assessed if payment is not made by the 10th of each month.

If a student is withdrawn during the year, *the tuition obligation runs through the end of that quarter.*

THIS IS A FINANCIAL CONTRACT – Read carefully and sign. Keep a copy for your records.

Based on the above information, I realize that my registration fee is not refundable, and that the monthly tuition payments for my child are due on the first of every month, starting August 1st. I also realize if I withdraw my child from school during the year, I will be obligated to pay the remainder of the quarter's tuition.

After May 31st, if I withdraw my student, I understand I will be obligated to pay the 1st month of tuition and if I withdraw my student after July 31st, I will be obligated to pay the first quarter of tuition. Initial here: _____
