## CONTINUING RESOLUTION

## CR12.04.F22. TRINITY ART COMMITTEE

WHEREAS, this congregation is committed to the ministry of Jesus Christ through all possible means, including Church art; and

WHEREAS, this congregation has substantial investments from acquisitions, memorials, gifts, and bequests, in artworks; and

WHEREAS, the Congregation Council is responsible for maintaining and making available this congregation's resources for the spiritual growth of our members; and

WHEREAS, the Congregation Council has made its artworks an area of concern for the Worship & Music Committee (most recent CR12.15.B.), which committee is a standing committee of the Congregation Council (B12.15.02.);

THEREFORE, BE IT RESOLVED that Trinity Evangelical Lutheran Church, Latrobe, PA (hereafter church) shall maintain a Trinity Art Committee, which committee shall operate as a subcommittee (B12.15.03.b.) to the Worship & Music Committee (B12.15.02.i.) of the Congregation Council. The Trinity Art Committee shall function and operate as described below.

## I. FUNCTION

- 1. Recommend, as appropriate, specific artworks for acquisition or restoration by this congregation or needed enhancements to the resources and housing of this congregation's artworks, for consideration by either the Memorial Fund Committee [(most recent CR12.05.D.) for consideration of placement onto the Memorial Fund list (most recent CR12.05.D.)], Special Gifts Committee [(C13.05.) for consideration of appropriate endowment fund(s) usage], or, dependent upon approved budget authority, the Worship & Music Committee (B12.15.02.i.) or the Congregation Council.
- 2. Consider requests from any member(s) of this congregation, either referred or not referred to the committee by the Congregation Council, concerning any proposed addition(s) to this congregation's artworks.
- 3. Maintain an inventory and be curator of this congregation's artwork. Arrange for the appropriate showing of paintings, photographs, wall hangings, and statuary. Oversee any artwork restorations undertaken by this congregation.
- 4. Maintain guidelines for the acceptance of art works either through acquisition by or gift to this congregation.

## II. OPERATION

- 1. Trinity Art Committee should include at least three (3) voting members of this congregation (\***C8.02.c.**), including, as an ex-officio member, the ministry staff member who relates to the Worship & Music Committee (B12.15.02.i.). Members of the Trinity Art Committee should be approved annually by the Worship & Music Committee. There is no limitation on length of continuous service on the Trinity Art Committee.
- 2. The chairperson of the Trinity Art Committee may be elected annually by the committee and approved (B12.15.03.b.) by the Worship & Music Committee (B12.15.02.i.) or shall be appointed annually by the Worship & Music Committee. There is no limitation on consecutive terms as chairperson of the Trinity Art Committee.
- **3**. The Trinity Art Committee should strive to meet at least semi-annually and shall meet at the request of the chairperson of the Trinity Art Committee (II.2.), the Worship & Music Committee (B12.15.02.i.), the Congregation Council, an ELCA rostered ministry staff member of this congregation, or officer (C11.01.) of this congregation.
