But let’s see what our five youngsters had to say about their involvement in this increasingly popular sport.

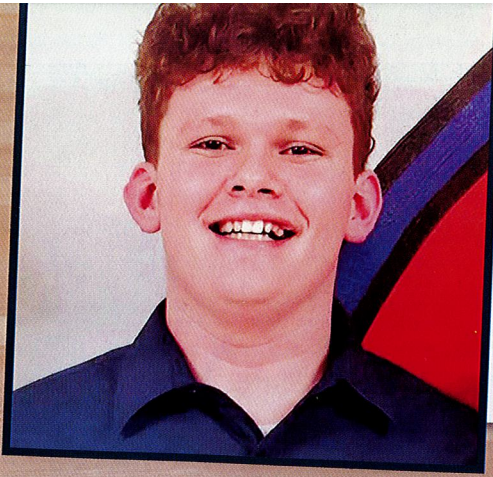


**GRACELYNN** I have done archery for the past four years. Going on to my fifth year, archery is just pretty natural to me.

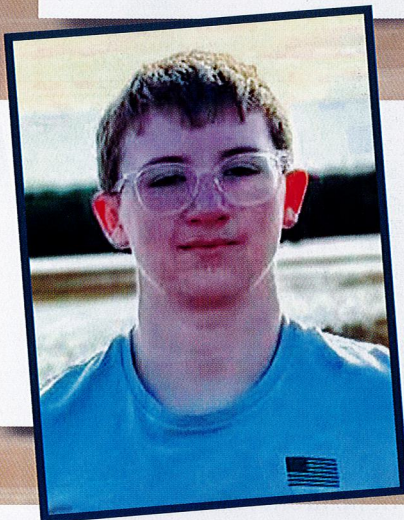


**HUNTER** The best thing about this archery season was learning and improving. I did a lot of improving. It taught me to be more patient with myself and how I do things.
