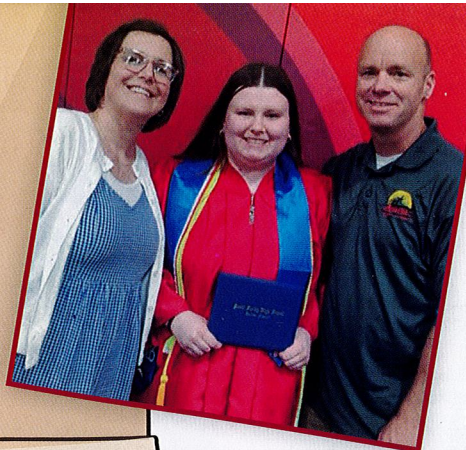
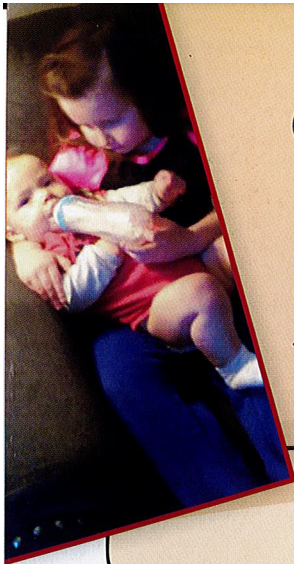

As soon as they realized we needed a safe place to live, they drove four hours to Springfield, Missouri, in the middle of the night to bring us home.

Being back at Shiloh felt right. Shiloh has always felt like home to me, and I am deeply grateful for that.

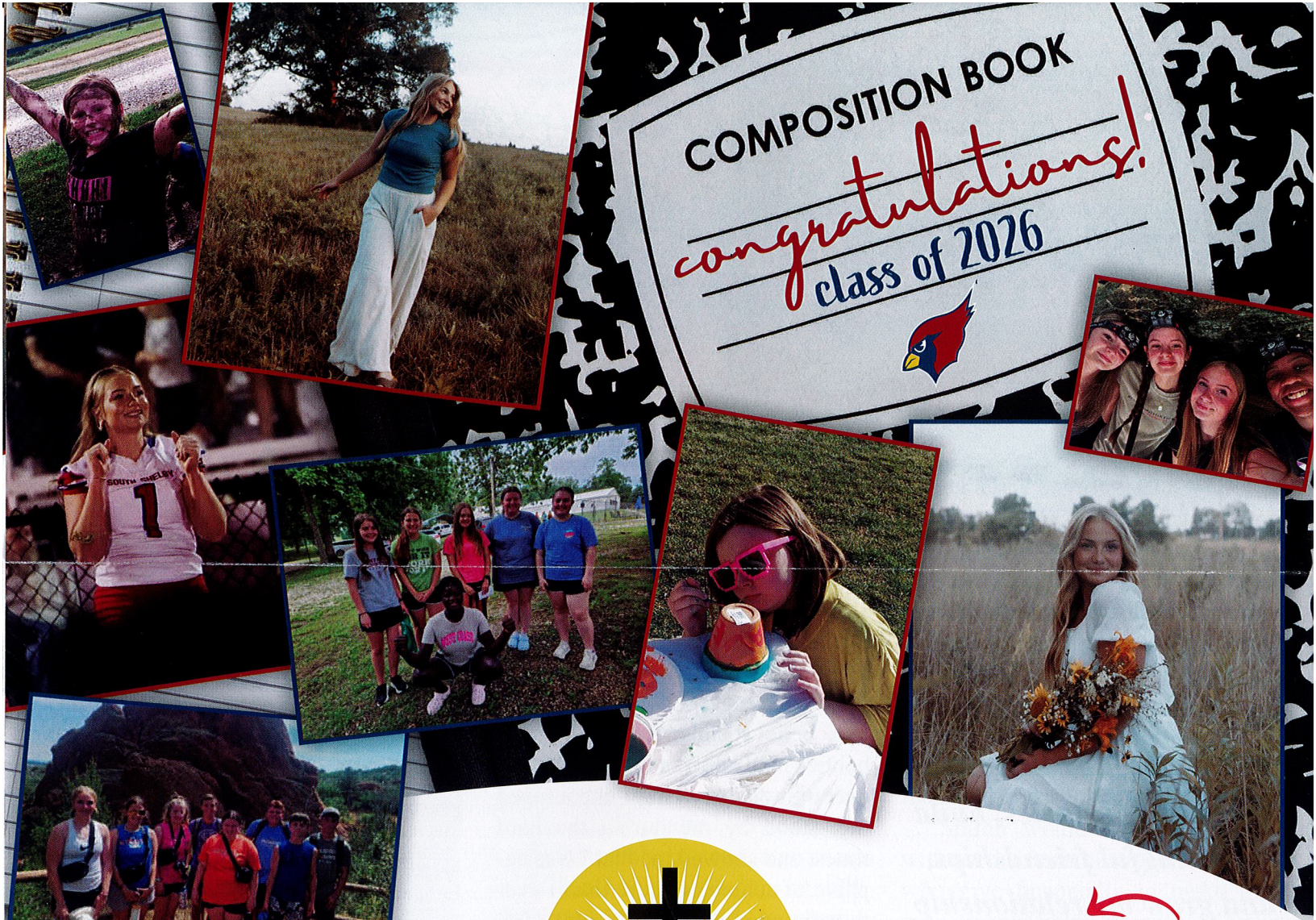
I am incredibly grateful not only for my parents but for every house parent at Shiloh. They all served as amazing examples of how Christ shows His love to others. They taught me that even when you mess
