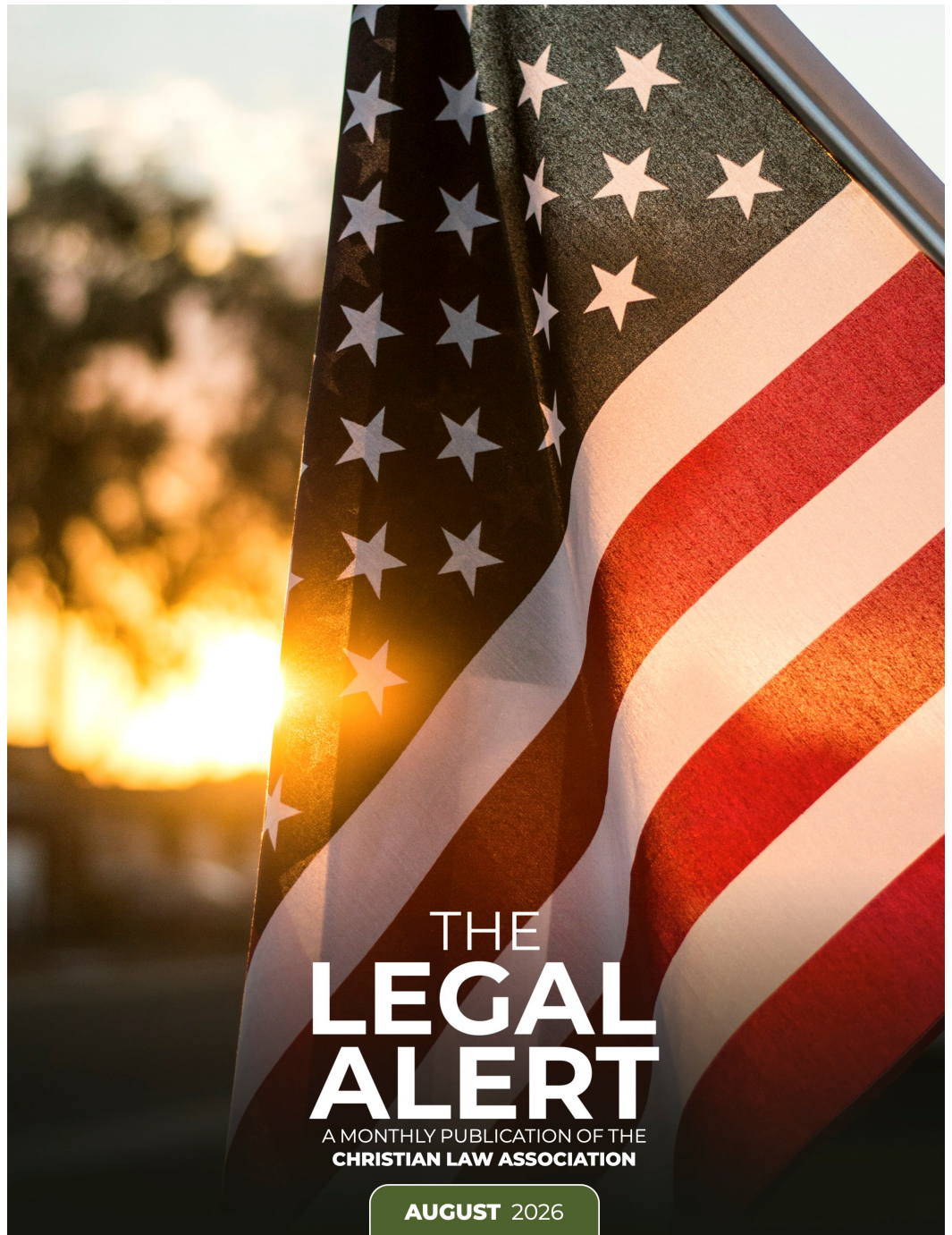

AS SUMMER ENDS...THE MINISTRY NEVER DOES

As families return from vacations and children prepare to head back to school, many churches begin one of their busiest seasons of the year. Sunday school classes resume, Bible studies begin again, choirs restart rehearsals, Christian schools welcome students, and ministries that may have slowed during the summer quickly regain momentum.

While schedules become fuller, our calling remains unchanged.

The Apostle Paul reminded believers, "Therefore, my beloved brethren, be ye steadfast, unmoveable, always abounding in the work of the Lord..." (1 Corinthians 15:58a).

Thank you for praying. Thank you for giving. Together, by God's grace, we continue defending those who faithfully proclaim His Word.

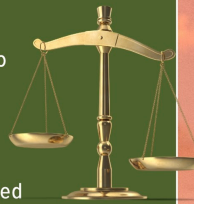
