



Parent Consent and Release Form

Consent & Release Information

I, the undersigned, am the parent or legal guardian of the minor child/youth named above, and do hereby give consent for my minor child/youth to attend and participate in Calvary Murrieta Christian Academy/Calvary Chapel Murrieta ("Calvary Murrieta") children/youth events.

The accident waiver and release of liability shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.

Participation Agreement/Liability Release

I acknowledge that participation in any homeschool or church-related activities involves risk to the participant (and to the participant's parents or guardians, if the participant is a minor), and may result in various types of injury including, but not limited to, sickness, exposure to infectious or communicable disease, bodily injury, death, emotional injury, personal injury, property damage, and financial damage.

In consideration for the opportunity to participate in any such activities (the "activities"), the participant (or parent/guardian if the participant is a minor) acknowledges and accepts the risks associated with participation in and transportation to and from these activities. The participant (or parent/guardian) accepts personal financial responsibility for any injury or other loss sustained during the activities or transportation, as well as for any medical treatment rendered to the participant that is authorized by the sponsor or its agents, employees, volunteers, or other representatives (collectively referred to as the "activity sponsor"). Further, the participant (or parent/guardian) releases and agrees to indemnify, defend, and hold harmless the activity sponsor from any injury arising directly or indirectly out of participation in these activities or transportation to and from the activities, whether such injury arises from the negligence of the activity sponsor, the participant, or otherwise.

If a dispute over this agreement or any claim for damages arises, the participant (or parent/guardian) agrees to resolve the matter through a mutually acceptable alternative dispute resolution process. If an agreement cannot be reached, the dispute will be submitted to a three-member arbitration panel in accordance with the rules of the American Arbitration Association.

Medical Release

In case of accident, illness, or injury, I hereby give my consent for the above-named child to be treated by emergency personnel and/or be transported to the nearest hospital in case of accident or injury. I hereby authorize Calvary Murrieta Christian Academy/Calvary Murrieta staff and/or parent volunteers into whose care such minor has been entrusted, to consent to any X-ray examination (or similar examination such as by CAT scan), anesthetic, medical or surgical diagnosis or treatment and hospital care to be rendered to the minor under the general supervision and upon the advice of a physician and surgeon licensed under the provisions of the Medical Practice Act or to consent to an X-ray examination, anesthetic, dental or surgical diagnosis or treatment and hospital care to be rendered to the minor by a dentist licensed under the provisions of the Dental Practice Act. I agree to accept financial responsibility for the costs related to medical treatment.

Media Release

I hereby give my permission for Calvary Murrieta Christian Academy/Calvary Murrieta to photograph, film, videotape and/or make sound recordings of my child, to quote or to publish statements of my child and to use such photographs, films, videotapes, sound

recordings and/or other statements for educational and promotional/advertising materials. I understand that images and videos may be used in print publications, online publications, presentations, websites, and for social media purposes. I also understand and agree that no royalty, fee, or other compensation shall become payable to me by reason of such use. I release Calvary Murrieta Christian Academy/Calvary Murrieta from all liability with respect to the matters covered by this release.

Check-In and Registration Authorization

Calvary Murrieta utilizes Shelby Registration to keep your minor child/youth safe while at children/youth events. Shelby Registration is a security and safety program that requires parents to sign up online and register their children. I, the undersigned, do hereby give consent to use Shelby Registration and to give authority to register my minor child/youth to every individual included on the Shelby Registration account.

Transportation Release

I, the undersigned, do hereby give, consent for my child/youth to ride in any vehicle by an approved and licensed adult chaperone while attending and participating in activities sponsored by Calvary Murrieta Christian Academy/Calvary Murrieta. For youth events, an approved and licensed adult chaperone may be under the age of 25 years old.

I CERTIFY THAT I HAVE READ THIS DOCUMENT, AND FULLY UNDERSTAND ITS CONTENT. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY AND A CONTRACT AND I SIGN IT OF MY OWN FREE WILL ON BEHALF OF MYSELF AND MY DEPENDENT.
