



Agreement Between Center and Parent

The following conditions will apply to the daycare attendance of _____

with regard to whom it is understood and agreed between Fairview Child Development Center

THIS CENTER AGREES THAT:

In return for the sum which the parent agrees to pay, the center will accept the above named child for attendance for the times and days per week agreed upon with the center, except on the following holidays:

New Year's Day (observed on January 4, 2027)	Labor Day (First Monday in September)
Good Friday (the Friday before Easter)	Veteran's Day (November 11)
Memorial Day (last Monday of May)	Thanksgiving Break (Wednesday-Friday)
Independence Day (July 4)	Christmas Eve and Christmas Day
**Summer Break (July 27-31,2026), (July 26-30,2027)	**Winter Break (December 28, 2026-January 1,2027)

**These are dates you do not pay for.

1. The Daycare worker will observe daily the children in attendance for symptoms of contagious diseases or illnesses before they are admitted for the day. If the child has a fever, he/she will not be admitted and should not be returned by the parent until free of an elevated temperature for 24 hours.
2. We will exercise ordinary, reasonable care and judgment in all matters related to the welfare and safety of all the children.
3. In case of an accident or illness of the child, the daycare worker will promptly take such measures as are, in his/her judgment, in the best interest of the child and will notify parents as soon as possible.
4. It will furnish, in addition to custodial school care, the following services: morning and afternoon snacks, as well as emotional, social, and mental development opportunities in a group situation.
5. The Center **will NOT provide** accident insurance coverage.
6. The Center will give notice to parents in the event of discovery of any exposure to a contagious disease within the daycare group.
7. The Center will not release the child to anyone except the parent or guardian, unless there is written permission from such parent or guardian.
8. The Center will provide toys and equipment in sufficient quantity to allow for a variety of play and learning activities during the day.

THE PARENT AGREES THAT:

1. The parent will pay the Center in advance the sum agreed upon, on or before Monday of each week. Parent will not violate and will comply exactly and punctually with the hours of agreed care.
2. The Parent will pay the Center for every week regardless of absences, holidays, sickness, or school closings. The only 2 weeks the parent will not pay is the two weeks a year the Center is closed.
3. If your child needs medicine during the day, parent must provide the medicine and leave written instructions on the appropriate form of the dosage and the hour the medicine is to be given. The medicine must be in original container, clearly labeled. *We do not give fever reducers/pain relievers for any reason*
4. In case of illness or accident of a child, and if parent cannot be located for contact by the School, and in the judgment of the worker the illness or accident requires a physician, then the doctor listed on the registration form may be called at the parent's expense.
5. In the event of contagious illness of a child, parent will notify the school and remove the child and not allow him or her to return until all danger of contamination is past.
6. The Center reserves the right and privilege to dismiss from attendance at the school any child who, after entering, is determined by daycare personnel to be unable, for any reason, to participate in the group experiences provided or arranged by the School.
7. The Parent and child are responsible and have liability for the acts of the child, and all damages resulting in injury to, or destruction of, any property, real, personal, or mixed while in attendance at the school or under the supervisory care of the Center.
8. Neither FCDC, nor Fairview Church of God shall be liable for accidents or illnesses occurring to the child while in attendance or under the care of the Center, and parent will protect, indemnify, and hold harmless all of them from any liability, or claims for damages for such accidents or illnesses, unless it be proved that the accident or illness was the direct result or consequence of misconduct of the agencies and employees of the center or church.
9. Parent will give two (2) weeks notice when child is to be withdrawn from school.
10. Parent did receive handbook entailing rules and regulations of the Center and agrees to abide by the statues therein.
11. FCDC will not resume responsibility for a child who is not signed in by parent, guardian or approved pickup upon arrival each day.

BOTH PARTIES AGREE:

Immediate termination will result from:

- Parent Bullying
- The child listed above becomes dangerous to teachers and/or students
- The parents/caregivers and the center cannot come to an agreement on continuing care
