

FIRST BAPTIST CHURCH OF ALEXANDRIA
STUDENT PERMISSION and RELEASE FORM

This form (1) gives your permission for your child to ride in transportation provided by First Baptist Church of Alexandria (FBCA); (2) gives permission for your child to participate in FBCA student activities; (3) releases FBCA and its staff and volunteers from liability related to your child's participation in FBCA student events; (4) gives FBCA group leaders authorization to secure medical aid for your child should it be necessary during a youth event; (5) allows for the release of your student following FBCA Student Ministry activities in accordance with FBCA procedures; and (6) grants permission for FBCA to photograph or record your student for church-related purposes in accordance with FBCA policies. This waiver applies to students participating in FBCA Student Ministry programs for middle school and high school students.

In consideration of FBCA permitting my child, _____, (Print Minor Child's Name), hereinafter, "Child" or "Student" to participate in FBCA student trips, activities and outings including recreation and work activities (FBCA Student Events), I, _____, (Print Parent/Guardian's Name), do hereby give the following permissions and releases:

(1) Transportation Permission

I hereby give permission for my Child to be transported to and from FBCA Student Events in FBCA vehicles or other transportation arranged by FBCA.

(2) Event Participation Permission

I further grant my Child permission to participate in all FBCA Student Events.

(3) Release of Liability

I do hereby release, forever discharge and agree to hold harmless FBCA, its members, employees, representatives, agents, assigns and volunteers (FBCA Releasees) from any and all liability, claims or demands for personal injury, sickness or death, as well as property damage and expenses, of any nature whatsoever which may be incurred by my Child that occur while my Child is participating in any FBCA Student Event. I further hereby agree to hold harmless and indemnify FBCA Releasees for any liability sustained by my Child, including expenses incurred attendant thereto. This release does not apply to acts of gross negligence, willful misconduct, abuse, or violations of FBCA's Child Protection Program or applicable law.

(4) Medical Treatment Authorization

I further authorize representatives of FBCA to obtain or acquire medical care and treatment necessary as a result of injury or illness occurring while my child is participating in a FBCA Student Event and to utilize my insurance policy for such care. Medical care professionals are authorized to furnish care as directed by the representative of FBCA presenting this document.

(5) Release of Students from Events

I hereby give permission for my Child to be released from FBCA Student Ministry events at the conclusion of that event. This lets your student be released from Events such as Sunday morning Bible study and meet you in the sanctuary. Release of students will occur in accordance with FBCA's established student supervision and release procedures for Student Ministry.

(6) Photography Waiver

Staff and volunteers may take photographs/videos of children during church-sponsored groups and events for First Baptist Church of Alexandria purposes. Minors are not identified by name on any public platform, except for specific occasions, such as baptisms, when parents are informed in advance. Due to the nature of large-group events or when children are participating in a worship service/presentation from the platform in the Sanctuary or other featured locations, we are unable to ensure that individual children or groups of children will not be included in photos and videos at these times. Parents who prefer not to have their children's photos taken or for them to be recorded in videos in individual or small group settings may have their student grab a brightly colored wristband from the table in the student ministry space.

Effectiveness and Revocation

This permission form and release shall remain in full force and effect until revoked in writing.

By signing, you are agreeing to the above sections and acknowledge that FBCA maintains a Child Protection Program and that all student activities are governed by its safety, supervision, and reporting requirements."
