In consideration of the risk of injury while I, or my minor are attending and participating in activities on Student's Camp 2023 (henceforth referred to herein as the "trip"), sponsored by Great Life Church, Inc. and as consideration for the right to participate in the daily routine and activities during this trip, I, \_\_\_\_\_ hereby, for myself, my heirs, my minor(s), executors, administrators, assignees, or personal representatives, knowingly and voluntarily enter into this waiver and release of liability and hereby waive any and all rights, claims, or causes of action of any kind whatsoever arising out of my participation in the day to day activities of this trip, along with all travel time required to participate, and do hereby release forever, discharge and agree to hold harmless Great Life Church, Inc. located at 14494 Cortez Blvd., Spring Hill, FL, 34613, their pastors, directors, employees, volunteers and teachers their affiliates, managers, members, agents, attorneys, staff, volunteers, heirs, representatives, predecessors, successors, subsidiaries and assignees, (collectively herein the "Church") from any physical or psychological injury, including but not limited to illness, paralysis, death, damages, and economical or emotional loss that I, or my minor may suffer as a direct result of my participation in the aforementioned activities, including traveling to and from all related events.

I understand that I / my minor is voluntarily participating in this event and participating at my / their own risk.

I agree to indemnify and hold harmless Great Life Church, Inc. against any and all claims, suits, or actions of any kind whatsoever for liability, damages, compensation or otherwise brought by me or anyone on my behalf, including attorney's fees and any related costs, if litigation arises pursuant to any claims made by me or by anyone else acting on my behalf. If Great Life Church Inc. incurs any of these types of expenses, I agree to reimburse Great Life Church, Inc. the full amount of such fees to its fullest extent and cost, including those fees attributed to Great Life Church, Inc. because of damages attributed to myself or my minor whilst on the trip.

I acknowledge that Great Life Church, Inc. and their directors, officers, volunteers, representatives, and agents are not responsible for errors, omissions, acts, or failures to act of any party or entity conducting a specific event or activity on behalf of Great Life Church, Inc.

I acknowledge that I have carefully read this "Waiver And Liability Release" and fully understand that it is a release of liability. I expressly agree to release and discharge Great Life Church, Inc. and all of its affiliates, managers, members, agents, attorneys, staff, volunteers, heirs, representatives, predecessors, successors, and assignees, from any and all claims or causes of action and I agree to voluntarily give up or waive any right that I otherwise have to bring a legal action against Great Life

Church, Inc. for personal injury, property damage or any and all financial or legal responsibility that may be attributed to Great Life Church, Inc. while I or my minor are on the trip .

To the extent that statute or case law does not prohibit releases for negligence, this release is also for negligence on the part of Great Life Church, Inc. its agents, and employees etc.

In the event that I should require medical care or treatment, I agree to be financially responsible for any costs incurred as a result of such treatment. I am aware and understand that I should carry my own health insurance.

In the event that any damage to equipment or facilities occurs as a result of my willful actions, neglect, or recklessness, I acknowledge and agree to be held liable for any and all costs associated with any actions of neglect or recklessness.

Any who decline to have individual liability insurance realize that they travel at their own risk and free will and Great Life Church, Inc. its executors, administrators, assignees, personal representatives, board etc. are not held liable in any way.
