### MINUTES

**Special Guests** – Secretary Jeff Noel, Kentucky Cabinet for Economic Development.

**Call to Order** – Trigg County Judge Executive and PeADD Board Chair, Hollis Alexander, called the meeting to order at 12:02 pm with a quorum present. The meeting was conducted in-person at the PeADD office.

**Pledge of Allegiance & Invocation** – Mr. Terry Stringer led the pledge and Judge Curtis McGehee led the invocation.

**Approval of Minutes** – The July 11, 2022 Board of Directors Meeting minutes were presented for review and approval. There were no questions or comments. Mayor Arthur Green made a **MOTION** to approve the minutes as presented. Judge Garrett Gruber seconded the motion and the motion passed.

**Approval of Financial Report** – Ms. Alisha Sutton, Administrative Officer, presented the July 31, 2022 Monthly Expenditure Report for review and approval. All line items are within budget at \$646,219.10 (3% expended) year-to-date. There were no questions or concerns. Scott Marshall made a **MOTION** to approve the financial report as presented. Mayor Bill Hesser seconded the motion and the motion passed.

**Federal & State Reports** – Brief comments were provided by Mr. Austin Wetherington representing Congressman Comer's office, State Representative Walker Thomas, Alex Caudill with Department for Local Government and Doug Taylor with Kentucky Transportation Cabinet and Rural Aid.

#### Reports -

1. **West Kentucky Workforce** – Sheila Clark, WKWB Director, gave a brief update on workforce activities and discussed upcoming job fairs happening in the area to include the Step Into A Job – Hiring Event to be held on Thursday, September 15, 2022 at The Bruce Convention Center in Hopkinsville. Derek Poor, Veterans Transition Liaison, provided an update on Fort Campbell job fairs and employment activities.

#### New Business

1. **Monthly Code of Ethics Report** – Judge Hollis Alexander, Board Chair, stated no Code of Ethics issues or violations were reported during the month.
2. **Guest Speaker** – Jeff Noel, Secretary of the Kentucky Cabinet for Economic Development shared his background and experience in economic development and explained how it influences his vision of collaboration and how it is the most significant aspect of Economic Development. He believes his spirit of winning and determination to get a job done are the fundamental assets he brings to the Cabinet. Secretary Noel detailed that he believes in integrity and hard work and how those essential qualities are needed at the Economic Development Cabinet in order to create that environment for businesses in Kentucky. He stated that his vision could be obtained very easily and gave credit to Governor Beshear in creating an innovative environment in Kentucky. He indicated that the state has a future, a vision and a core that keeps Kentucky from being left behind. Secretary Noel stated that he ultimately wants to create a sense of community in all of Kentucky where families can grow and dream of their future right here in the bluegrass state. To do that, he said, we have to have sustainable and well-paying jobs that will make them feel comfortable enough to do so.
3. **Director's Report** – Jason Vincent, PeADD Executive Director acknowledged Mr. Carter Hendricks, Executive Director of South Western Kentucky Economic Development Council and asked him to speak on the topic. Mr. Hendricks discussed the plans for Ascend Elements Inc. to invest \$310 million and create 250 full-time jobs in Christian County. He mentioned the collaboration it takes to make a plan of this magnitude to come to fruition. He mentioned the many partners, state and local leadership and local elected officials that come to the table when these discussions

occur. Mr. Hendricks discussed how this is not only a celebration for Christian County, but also for the entire PeADD region as 1/3 of the employees will likely come from other counties.

Mr. Vincent then spoke about the floods in Eastern Kentucky and asked Judge Jack Whitfield of Hopkins County, who had spent some time in Eastern Kentucky last week, to discuss the sights and needs of the region. He told the crowd that Knott County, where he visited, was a high poverty area that had destruction of homes and businesses due to the overflow of creeks. He provided insight to Knott County's Judge Executive on how to organize their relief efforts as Hopkins County had experienced devastation from the tornados in December of 2021. He said their main need would soon be building supplies as their significant damage was related to infrastructure.

Mr. Vincent then called Judge Perry Newcom of Crittenden County to briefly discuss the strides being made regarding Lake George, the primary water source in Marion, KY. Judge Newcom immediately thanked the board for their help during the drought over the last several months in providing water, time and resources to the city. He stated that the situation is much better and they are transitioning into the long-term planning now that the short-term crisis is under control.

Lastly, Mr. Vincent mentioned the return of The Pride of the Pennyriple, an industry appreciation event, to be held on September 22, 2022 at Lake Barkley State Resort Park. He went on to introduce a new employee, Jessica Meredith, the newly hired Community & Economic Development Specialist at PeADD.

**Other Business** – There was no new business.

**Adjourn** – With no further business, Judge Wade White made a **MOTION** to adjourn at 1:10 PM. Judge Steve Tribble seconded the motion. The motion passed.

### **MEMORANDUM**

**RE:** Availability of Hazard Mitigation Grant Program Funds

On July 29, 2022, Kentucky received Presidential Disaster Declaration FEMA-4663-DR-KY as a result of Severe Storms, Flooding, Landslides, and Mudslides occurring between July 26, 2022 and August 11, 2022 which affected 20 counties.

In conjunction with this declaration, federal funds are now available through the Federal Emergency Management Agency (FEMA) Hazard Mitigation Grant Program (HMGP) for eligible projects which will reduce damages from future events.

FEMA HMGP funds will cover 75% of the eligible costs of an approved project with the non-federal share typically split between the state (12%) and the local applicant (13%). The local share may be general funds, in-kind services directly related to the project, or funds received from other sources which can be used to match federal funds.

HMGP projects must demonstrate a permanent reduction in future disaster damages, pass a benefit cost analysis (if required), and avoid negative impact to the project's environmental and historical surroundings.

Typical types of **REGULAR** eligible projects include the acquisition/demolition or elevation of flood-prone or landslide-prone structures, engineered storm water control projects, community tornado safe-rooms, flood-proofing of non-residential buildings, seismic retrofits, and utility protective measures.

Up to 10% of the HMGP funding may be used for **INITIATIVE** projects for which a benefit cost analysis is difficult or impossible to conduct. Typically, this category of funding has been awarded for outdoor warning sirens, NOAA weather radios, other types of warning systems, generators, and mitigation educational outreach projects.

Also, up to 7% of the available HMGP funding may be awarded for **MITIGATION PLANNING** projects. This funding can be used for both the development and updating of the State Hazard Mitigation Plan and Local Hazard Mitigation Plans.

HMGP funding received after a disaster declaration may be spent on eligible projects statewide. However, the current State Hazard Mitigation Plan gives first priority to funding projects in the declared areas.

Eligible applicants for HMGP project funds include state agencies, counties, cities, and certain quasi-governmental and non-profit agencies. Individual citizens are not eligible to apply for these funds.

Eligible applicants must also have a FEMA-approved Local Hazard Mitigation Plan. Hazard Mitigation Plans have been developed in each Area Development District for use by mitigation grant applicants. Applicants that have not developed their own plan are encouraged to contact their Area Development Districts for assistance and additional information.

The Kentucky Division of Emergency Management requires interested applicants to complete a *Mitigation Action Form (MAF)* using the *Community Hazard Assessment and Mitigation Planning System (CHAMPS)* to declare their interest in applying for HMGP funds and submit the completed MAF in CHAMPS no later than **Thursday, October 13**. All applicant and sub-applicant communities must be participants in the National Flood Insurance Program (NFIP) if they have been mapped through the NFIP with a Flood Hazard Boundary Map (FHBM) or a Flood Insurance Rate Map (FIRM) and have been identified as having a Special Flood Hazard Area. In addition, communities must be in good standing with the NFIP. Applicants and sub-applicants in communities which are not mapped under the NFIP are eligible.

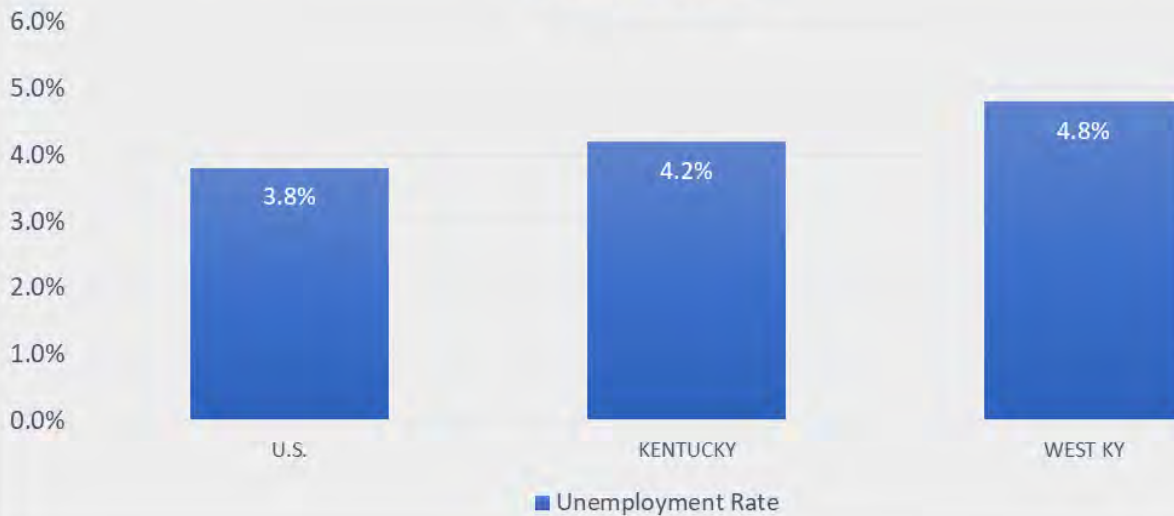

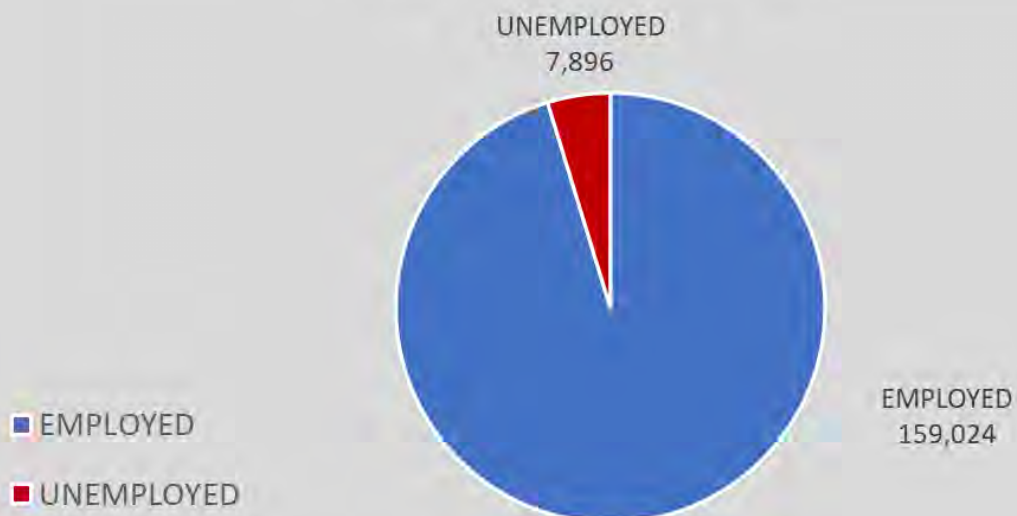

## Purchase / Pennyriple Local Workforce Area

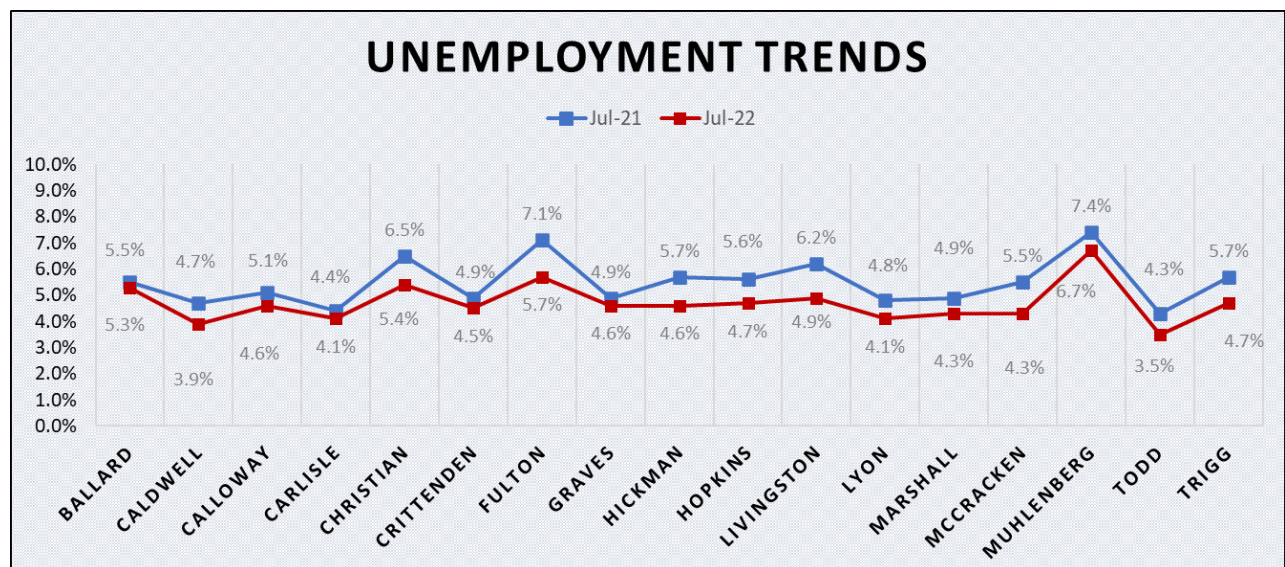

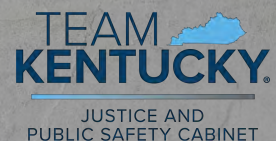

## **Department for Local Government Selects Three Area Development Districts as Peggy Satterly Award Winners**

*The award was presented at the 2022 Governor's Local Issues Conference by Senior Advisor to Gov. Beshear, Rocky Adkins. The award represents excellence in service to Kentucky.*

**LOUISVILLE, Ky.** (Aug. 22, 2022) – At last week's Governor's Local Issues Conference, Senior Advisor to Governor Beshear, Rocky Adkins, presented the Peggy Satterly Spirit of Kentucky Award to the Pennyriple Area Development District, Green River Area Development District and the Purchase Area Development District. The award represents excellence in service to Kentucky and is presented annually at the Governor's Local Issues Conference. The Area Development Districts (ADDs) were chosen for their work on the I-69 Corridor Development and the Ohio River Crossing project.

I-69 in Kentucky runs 148 miles from Fulton to Henderson. The final piece of the project includes constructing a bridge to connect Henderson with Evansville, Indiana. The project is expected to make Western Kentucky a more desirable location for business and relieve traffic regionally.

"The I-69 corridor project has been ongoing for decades, and these Area Development Districts have played a huge role in its success," said **Commissioner of the Department for Local Government Dennis Keene**. "This final piece will build on Kentucky's incredible economic momentum."

The award is named for Peggy Satterly who served the Commonwealth of Kentucky for 48 years, working with 11 Governor's administrations. She was regarded as an outstanding public servant. The Peggy Satterly Spirit of Kentucky Award is presented to the sponsors of a successful project that is the result of multiple government agencies working together in a cost-effective manner.

"The development of the I-69 Corridor in the Pennyriple Region has been an essential initiative since its origination in the 1991 Intermodal Surface Transportation Efficiency Act (ISTEA) and being a High Priority Corridor on the National Highway System," said **Jason Vincent, Executive Director of the Pennyriple ADD**. "Without the collaboration of local, state and federal partnerships, the corridor would not be a reality. We look forward to the completion of the Ohio River Crossing at Henderson and the numerous economic benefits I-69 generates."

"This award is also special to our region as it recognizes the hard work of our good friend John Mahre," **Director Vincent** continued. "John, like Peggy Satterly, had a passion for making the Pennyriple region and the entire Commonwealth of Kentucky a better place to live. We will miss John as he just recently lost a hard-fought battle to cancer. We're all better people for knowing and working with John." John Mahre was an accomplished architect and community advocate who served on the board of the Pennyriple ADD. In 2021, the Pennyriple ADD named its annual award for exceptional dedication and contributions to the region in John's honor.

The I-69 corridor in Kentucky mostly follows existing freeways originally built as toll roads. Upgrades were necessary to bring these freeways to interstate standards but required less work than constructing entirely new highway, saving millions in taxpayer dollars.

“On behalf of all the agencies and individuals who have come and gone over the years, the Purchase ADD is proud to share the Peggy Satterly Spirit of Kentucky award with the Pennyriple ADD and the Green River ADD,” said **Jeremy Buchanan, Executive Director of the Purchase ADD**. “Projects of this magnitude do not happen overnight and involve everyone’s help to see to completion. The improvements to the I-69 corridor have shown and will continue to produce positive results for those communities on the interstate corridor.”

“John Mahre was a resident of the Pennyriple area, he was always the face of the I-69 efforts and the project’s number one cheerleader,” **Director Buchanan** continued. “We echo the sentiments of the Pennyriple ADD that we are all better people for having known John.”

The project is divided into three sections. Work has begun on Section 1 of the project, which will extend I-69 by more than six miles and will include interchanges with KY 351, US 41 near Kimsey Lane and at US 60. Construction on the final piece, which will complete the I-69 connection from US 60 in Henderson to I-69 in Evansville, is anticipated to begin in 2027 and continue through 2031.

“Peggy Satterly epitomized a heart and passion for public service,” said **Executive Director of the Green River ADD Joanna Shake**. “To receive an award that pays homage to her work and legacy is extremely humbling and a tremendous honor. The ADDs understand the critical importance of partnerships and working together in advancing the Commonwealth. The I-69 Corridor Development exemplifies how unified efforts cultivate and deliver impactful economic results and improved quality of life.” **Director Shake** continued, “John Mahre recognized this as well and his advocacy, work and mission mirrored those of Peggy’s. Our region is profoundly better because of his efforts.”

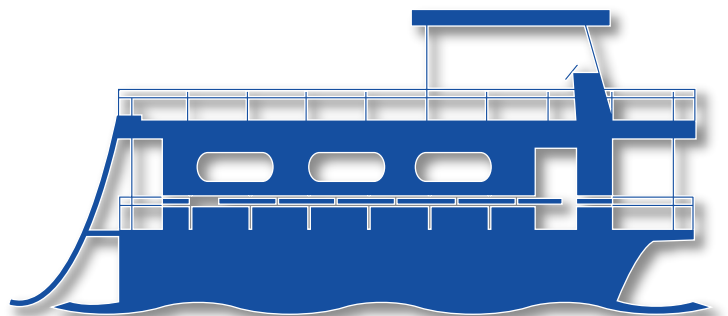

The CEDS provides the capacity-building foundation by which the public sector, working in conjunction with other economic actors (individuals, firms, industries), creates the environment for regional economic prosperity. Simply put, a CEDS is a strategy-driven plan for regional economic development. A CEDS is the result of a regionally-owned planning process designed to build capacity and guide the economic prosperity and resiliency of an area or region. Social workers collaborate with the client and family to identify areas of need and develop an individualized plan of care. Social workers also provide all the training and support to ensure the client receives the care he/she needs to promote independence with fervent hope to prevent the client from being institutionalized.

- environmental and minor home adaptation
- home delivered meals
- non-specialized /specialized respite care

## West Kentucky Regional Job Fair a Success

On Tuesday, August 23rd, the West Kentucky Workforce Board and its partners sponsored the West Kentucky Regional Job Fair at the Paducah-McCracken County Convention Center. A total of 101 employers and five service agencies filled the convention center to capacity. Over 400 job seekers attended the event, with half of the attendees living in McCracken County. Other job seekers drove from as far as Owensboro and Hopkinsville. Nearly half of the job seekers reported that they were already employed, but were attending the event to help create a career change. Since the job fair, employers have been reporting their delight on finding candidates to fill their positions.
