RESOLUTION NO. 2026- 12**

**A RESOLUTION OF THE CHRISTIAN COUNTY FISCAL COURT APPROVING A
SITE LICENSE AGREEMENT WITH TOWERCO 2013, LLC FOR THE
COLLOCATION OF COUNTY MICROWAVE EQUIPMENT AT SITE KY0091 AND
AUTHORIZING THE COUNTY JUDGE EXECUTIVE TO EXECUTE THE
AGREEMENT ON BEHALF OF THE COUNTY.**

WHEREAS, the Christian County Fiscal Court (the “Fiscal Court”) is the governing body of Christian County, Kentucky, a political subdivision of the Commonwealth of Kentucky, with authority to enter into contracts on behalf of the County pursuant to KRS Chapter 67; and

WHEREAS, Christian County has historically maintained microwave dish equipment on a communications tower located at 4157 Old Madisonville Road, Hopkinsville, Kentucky (Site KY0091), in connection with the County’s public safety and emergency management communications system; and

WHEREAS, the tower is now owned by TowerCo 2013, LLC, a Delaware limited liability company (“TowerCo”), and TowerCo has proposed a Site License Agreement to formalize the County’s continued use of the tower; and

WHEREAS, the County intends to transition its microwave equipment to County-owned infrastructure and therefore requires only a short-term arrangement; and

WHEREAS, the Fiscal Court has reviewed the Site License Agreement, as negotiated and revised by the County Attorney, and finds that its terms are reasonable and in the best interest of the County;

NOW, THEREFORE, BE IT RESOLVED by the Christian County Fiscal Court as follows:

Section 1. Approval of Agreement. The Site License Agreement between Christian County, by and through its Fiscal Court, and TowerCo 2013, LLC for the County’s collocation of microwave equipment at Site KY0091 (the “Agreement”) is hereby approved in substantially the form presented to the Fiscal Court.

Section 2. Key Terms. The Agreement contains the following material terms:

- (a) **Term:** Month-to-month, commencing on the Effective Date, terminable by either party upon thirty (30) days' prior written notice, with the County retaining the right to terminate for convenience at any time without penalty.
- (b) **Base License Fee:** One Thousand Six Hundred and 00/100 Dollars (\$1,600.00) per month, with no annual escalation.
- (c) **Site:** TowerCo Site KY0091, located at approximately 4157 Old Madisonville Road, Hopkinsville, Christian County, Kentucky.
- (d) **Permitted Use:** Public safety and emergency management communications.

Section 3. Authorization to Execute. The Christian County Judge Executive is hereby authorized and directed to execute the Site License Agreement, and any related documents reasonably necessary to effectuate the same, on behalf of Christian County, with such non-material changes as may be approved by the County Attorney.


Section 4. Payment. The Christian County Treasurer is authorized to make payments due under the Agreement from funds duly appropriated for such purpose.

Section 5. Effective Date. This Resolution shall take effect immediately upon its adoption.
