Behavioral Contract, Waiver of Liability, Medical Release

The event is designed to provide a fun, memorable, and safe experience that celebrates our seniors in a way that is meaningful to them. In order to maintain these goals, attendees and their parents/guardians must agree to the following:

1. I understand the Grad Night Party is not a school-sponsored event and has no relation to any high school in the Peninsula School District.
2. I understand this is a drug- and alcohol-free event. I will not bring alcohol or drugs onto the premises of the party, nor will I arrive at the party under the influence of any substance. The GHHS Parent Committee reserves the right to deny entry to any attendee who appears to be under the influence or unwilling to comply with event rules.
3. I agree to submit to a bag check.
4. I agree to be respectful at all times during the party. I will be respectful to parent volunteers, PenMet staff, and the other students attending the party. I will not start or participate in fights. I will follow the rules of the facility.
5. I will not damage or steal property owned by PenMet Parks or others. I will be liable for stolen or damaged property. I understand the GHHS Parent Committee cannot be held responsible for any lost or stolen items. I agree to indemnify and hold harmless the GHHS Parent Committee from any claims, damages, or expenses arising from my actions during the event.
6. I understand that violation of any rules may result in denial of entry or removal from the event without refund, and a parent/guardian will be contacted for pickup.
7. I grant permission for the GHHS Parent Committee to use photographs or video taken during the event for future promotional purposes without compensation.
8. I acknowledge that participation in the Grad Night Party involves inherent risks including but not limited to injury, illness, property damage, and transportation-related risks. I voluntarily assume all such risks. I agree to release, waive, and hold harmless the GHHS Parent Committee, its volunteers, PenMet Parks, staff, and any affiliated organizations from any and all liability for injuries, damages, or losses arising out of or related to participation in this event, including but not limited to negligence to the fullest extent permitted by Washington State law.
9. In the event of an emergency, I authorize the GHHS Parent Committee and its representatives to obtain medical treatment for the attendee. I understand that every effort will be made to contact a parent/guardian prior to treatment. I accept responsibility for any medical expenses incurred.
10. I understand that the GHHS Parent Committee and its representatives are not medical professionals and are not responsible for the outcome of any medical care provided.
11. I understand that transportation to and from the event is the responsibility of the attendee and their parent/guardian. I understand that the GHHS Parent Committee

strongly encourages a parent/guardian to drop attendees off and pick attendees up at the end of the party. Attendees transport to and from the party at their own risk.

12. I understand that attendees are encouraged to remain at the event for its duration. However, once they leave, the GHHS Parent Committee is no longer responsible for them.
13. I understand the party ends at 2:00 am, and that I will not attempt to stay once the chaperones close the building.
14. I have read and understand this agreement and voluntarily agree to this waiver and release of liability.
15. I certify that I am 18 years of age or older* and legally able to agree to this waiver and release of liability. My parent/guardian's signature is still required below because they acknowledge awareness of this event and support my attendance. Their signature provides emergency contact authorization, but does not waive any rights on my behalf.
 - a. *If the attendee is under 18 years of age, the parent/legal guardian agrees to all terms on behalf of the attendee.

This agreement shall be governed by the laws of the State of Washington. If any portion of this agreement is found to be invalid, the remaining provisions shall remain in full force and effect.
